



MISSOURI MATERNITY HOME TAX CREDIT

The Missouri State Legislature has enacted a law allowing individuals and businesses that contribute to Our Lady's Inn and other Maternity Homes in the State of Missouri to claim a state income tax credit equal to fifty percent of their donation. This credit is in addition to the regular state and federal deductions claimed for charitable donations.

History...

On January 22, 1982, Our Lady's Inn opened as an emergency residential shelter for pregnant women and their children.



Thousands of expectant mothers have received shelter, support and guidance. Thousands of babies have been given the gift of LIFE and thousands of children have been housed and comforted at "OLI".

In 1997, Our Lady's Inn moved to our main location on South Compton at Meramec in south St. Louis City. This facility houses up to 18 women and their children and serves St. Louis City & St. Louis County.

In 2005, Our Lady's Inn opened the Bro. Loyola Transitional Housing Program (THP) four-family unit building. Families from OLI can stay in these apartments for up to 1 year in a more independent setting with support services provided by OLI staff.

In 2006, Our Lady's Inn expanded to St. Charles County. This additional location serves St. Charles County and surrounding areas and houses up to 18 women & their children in need of maternity home/ transitional housing and supportive services.

Programs...

- **Maternity home includes spiritual, emotional and physical support for women who choose life for their babies. Food, clothing, counseling and many other services are provided for pregnant women and their children in times of personal crisis.**
- **Nurses on staff ensure that the women and children we serve receive proper medical care and advocacy. They encourage maternal bonding and nurturing through parenting classes and other resources.**
- **Professional and support staff help mothers become self-sufficient and secure employment and stable housing. The women are also encouraged to reclaim chastity and abstain from sexual activity until marriage.**
- **OLI Transitional Housing provides independent apartment living, including supportive services toward family independence and stability.**
- **A-B-CEEs...a welcoming educational child care environment where children in transition can blossom and grow.**
- **CARING TOUCH...professional therapist on staff promotes emotional healing through individual counseling and support groups dealing with issues such as domestic violence, abuse, mental health, addiction and abandonment.**
- **AFTERCARE...stabilizes and strengthens former OLI residents and families by providing follow-up supportive services.**
