Determination Accomplishes a Hopeful Future

Expectant mom "Melissa" came to Our Lady's Inn with her two children. She had a mountain of financial challenges, but was determined to provide for her family. This determination, combined with the support and services offered at Our Lady's Inn, proved life-changing.

During her 8 months stay at OLI, Melissa worked both a full-time and a part-time job. She attended in-house classes, taking advantage of financial management education which included classes on budgeting, saving, and household finances. And she put what she learned into action. Melissa cleared all her debts, established a savings account and purchased a car to get her children to daycare and herself to work.

She worked on improving her interpersonal communication and conflict resolution skills and attended classes on parenting and life skills development.

Melissa and her family recently moved into their own apartment- one that provides safety and stability. She now has a home where she can raise and provide for her children. Melissa reports feeling a huge sense of accomplishment. She recognizes that her hard work has made these positive changes in her family's life possible. Yet, she is not finished striving to accomplish more. Her new goal is to utilize her strong administrative skills to embark on a business office career. She is focused on continued spiritual growth, along with physical and mental wellness for her family. Now, enrolled in our Aftercare Program, Melissa has ongoing support to help her achieve these goals.

Executive Director

Our Lady's Inn has undertaken an initiative to become a Trauma Informed Agency. A trauma informed approach to the delivery of our services has, at its core, an understanding of trauma and an awareness of its impact. Trauma refers to experiences that cause intense physical and psychological stress reactions. Trauma can be a single event, multiple events or a set of circumstances that is experienced as physically and emotionally harmful or threatening and has lasting adverse effects on one's physical, emotional, social or spiritual well-being.

Almost every woman we serve has had an experience of trauma; as have many of the children. Trauma Informed Care (TIC) is a strengths-based approach that emphasizes physical, psychological and emotional safety for both those who are survivors of trauma as well as for those who are on the front lines providing the support services.

As part of the wrap around services we offer our pregnant women we want to place greater focus on facilitating recovery from trauma.

This initiative will require ongoing education and training and an in depth look at our policies and processes. We are committed to "Living our mission through Trauma Informed Care".

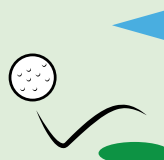
