# From the Chief Executive Office



With the purchase of land in St. Louis County completed, we look forward to finalizing the design plans for the newest Our Lady's Inn home. As we wrap up with architecture and landscape design work, we are deep into preparations for a

Capital Campaign to support the construction of the new home which will house twelve expectant women and their children in a loving and inviting environment.

If these efforts are not sufficient to occupy leadership's focus, we have initiated strategic planning. Every three years we develop a new strategic plan which outlines goals and strategies to guide our direction over the subsequent 3-5 year period. We have a professional consultant supporting us through

this process and have begun soliciting input from staff, volunteers, community partners, Board members, vendors, donors, grant funders and those we have served. We are using a survey tool which allows for anonymous feedback as well as in-person interviews. This 360° approach allows for a well-rounded perspective on how well Our Lady's Inn is and can be serving the community. We begin with the well-regarded SWOT analysis – looking at our agency's strengths as well as weaknesses; and considering what threats we may face in the future from external sources and identifying opportunities of which we can take advantage. We will establish measurable strategic goals and determine actionable steps to achieve such.

I ask for your prayers for the success of all our endeavors as we carry out the mission of supporting life and the mothers who choose it.

**How the Missouri Maternity Home Tax Credit works:**

A donation of \$100 or more may be eligible for Missouri Maternity Home Tax Credits equal to 70% of your donation amount. Donors may claim up to \$50,000 in tax credits per tax year; credits may not exceed taxpayer's state tax liability.

Tax credits which cannot be claimed in the tax year the contribution was made may be carried over to the succeeding tax year.

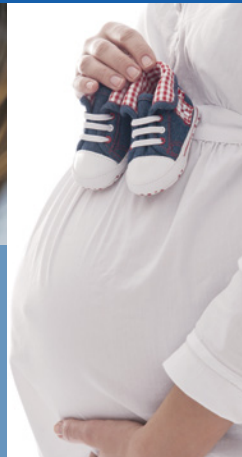
